## **IPA RIGHT TO PLAY AWARD PROGRAMME**

### **Call for Submissions**

The "IPA Right to Play Award" Programme was created to recognise and celebrate projects that utilise innovative and practical ways to implement Article 31 of the UN Convention on the Rights of the Child.

Appropriate projects include activity programs, public awareness campaigns, media products, implemented national or local legislation, design of spaces, and design of play items.

This award was launched at the IPA World Conference in Melbourne, Australia in 1993 and since then awards have been made at every Triennial World Conference. The awards provide an opportunity for winners and nominees to showcase their work to both their community and the world. Nominations are invited from organisations and individuals that represent profit or not for profit organisations.

Award winners will be announced at the Gala Dinner of the 20th Triennial IPA World Conference hosted in Calgary, September 2017 and featured on the IPA World website.

#### **CRITERIA**

To gain the award the following criteria must be met:

- Projects must demonstrate how they protect, promote and/or improve the child's right to play.
- Projects must respect and/or enhance local culture.
- Projects should not contradict any article of the UN Convention.
- Projects must have been implemented and assessed, including the impact on the children in the community.
- Projects must not be a commercially available product.
- Projects must have the ability to be replicated in other communities.
- Only one submission is allowed per organisation.
- Submissions must be in English.
- Each submission must be accompanied by a letter of authorisation to exhibit by the sponsoring organisation and to have the project promoted on the IPA World website.
- Project submission form and project submission must meet the deadlines advertised.



## HOW DO I APPLY?

Nominations for Projects that meet the criteria should be made on the Programme Submission form provided that includes a 100 word summary for the website and 2 photos for use on the website. This form is due by email no later than June 30th 2017.

The project is then to be recorded into a submission that provides more detail and is able to be displayed at the conference for participants and for judging to take place.

All submissions that meet the criteria will be exhibited throughout the conference and should be presented in one of the following 2 formats:

- **POSTERS** – Up to three posters. Each poster must be no larger than 100cm x 100cm. All printed text should be clear and at least 1cm high. Table space (directly in front of the poster) is also available for display. Visual material that makes the project self-explanatory is helpful, especially for viewers with English as their second language.
- **RINGED BINDER** - International 'A4' or letter size, 10 page maximum presentation. Clarity of print is important to accommodate those with English as a second language.

In addition a presentation or film may be provided on USB stick, however may not be used at the event but for later social media opportunities, dependent of the technology available at the conference.

## HOW WILL IT BE JUDGED?

Judging criteria will focus on innovations which implement Article 31.

Submissions will be judged during the World Conference with strict regard given to the criteria above. The Submission Form reflects those criteria.

All submissions meeting the entry criteria will be exhibited at the conference. Those presented the 'IPA Right to Play Award' will be put on the IPA Website.
